ADVENT

General Background on the Season.

Advent has a twofold character, for it is a time of preparation for the Solemnities of Christmas, in which the First Coming of the Son of God to humanity is remembered, and likewise a time when, by remembrance of this, minds and hearts are led to look forward to Christ's Second Coming at the end of time. For these two reasons, Advent is a period of devout and expectant delight.

Advent begins with Evening Prayer of the Sunday that falls on or closest to November 30th and ends before Evening Prayer of Christmas.

With the beginning of Advent is, too, the beginning of the new liturgical year. (Year B)

Advent Wreath. The use of the Advent wreath has become a popular practice in the Church. The Advent Wreath should be large enough to be visible to the members of the assembly in a given church building. In some churches, it is suspended from the ceiling. Others use a stand or a table for the wreath and candles. If the Advent Wreath is place in or near the presbyterium (sanctuary), it should not be placed in such a way as to interfere with the ritual actions of the liturgy or obscure the visibility of the altar, ambo, or presider's chair.

Vestments. The color of the Season of Advent is violet. In order to distinguish between Advent and Lent, the bluer hues of violet may be used. Blue vestments are not authorized for use in the United States and rose-colored vesture may be worn on the Third Sunday of Advent, which is termed *Gaudete Sunday*.

Music and Environment

During Advent, the playing of the organ and other musical instruments, as well as the floral decoration of the altar, should be marked with a moderation that reflects the character of this season, but does not anticipate the full joy of Christmas itself. The secular world focuses on decorating, shopping, and rushing towards the celebration of Christmas. However, the Church gives us the Season of Advent as way to practice discipline and patience in preparation for the great mystery of the Birth of Christ. Projecting the celebration of Christmas onto a season that is to be marked by waiting and spiritual preparation seems to miss the point of Advent.

As you are aware, present COVID-19 guidelines preclude us from singing in church and prevent the use of our melodious choir. As a substitute, Mike Dreelin has been downloading music from several sources, and we recently purchased a license to continue that practice. Our choir is not forgotten, however. They recorded the music we hear each Sunday during the lighting of the Advent wreath, and as a special treat, they will record carols for us to listen to before Mass on Christmas Eve. Thank you Carol, Mike, and the members of the choir.

NEW WORSHIP AREA

Site preparation has begun and the asphalt where the church will stand has ben removed and replaced with dirt and sand. The portico was removed this week. Handicapped parking is now available in front of the fountain. The church entrance and exit is now exclusively through the alcove doors.

December 13, 2020 3rd Sunday of Advent "Gaudete" Year B

The Third Sunday of Advent, 2020 Year B "Gaudete Sunday"

The third Sunday of Advent is called Gaudete Sunday because the opening antiphon of today's Mass says: "Gaudete in Domino semper" – "Rejoice in the Lord always." This is to remind us that we are preparing for the very joyful occasion of the birth of Jesus. And the main theme of this Sunday's Scripture readings is one of joy and encouragement. The readings urge us to make the preparations required of us as we await the most joyful event of lives. We are reminded that the coming of Jesus in our heart/lives is always a source and reason for rejoicing.

Prophet Isaiah, in the first reading, encourages the Jewish exiles returning from Babylon to rejoice because their God, Yahweh, is their strong Guide, Provider and Protector. Prophet Isaiah also rejoices because God has called to proclaim Good news to his people. Good news 'of glad tidings to the poor, to heal the brokenhearted, to proclaim liberty to the captives and release to the prisoners.' St. Paul, in the second reading, advises the Thessalonian Christians to "rejoice always" by leading blameless, holy, and thankful lives guided by the Holy Spirit, as they wait the coming of the Lord Jesus Christ, whose coming is near, he is faithful to all his promises.

Today's Gospel tells us that John the Baptist came to bear witness to Jesus as the Light of the world. The John wanted all the Jews to rejoice and be prepared to receive the long-expected Messiah, as the light of the world, who will remove the darkness of sin from the world. In humility John says I am not the one, but "I am the voice of one crying out in the desert, make straight the way of the Lord." John the Baptist was committed to preparing people and be a witness for the long-awaited Messiah. We too, like John, are chosen to bear witness to Christ Jesus, the Light of the world.

Our mission, as a Church, is to reflect Christ's Light to others. It is especially important during the Advent season that we reflect Christ's sharing love and his unconditional forgiveness through our lives. There are too many people who live in darkness and poverty, and who lack real freedom. Many others feel lonely, unwanted, rejected, and marginalized. Let us bring the true Light of Christ to illumine the lives of all these brothers and sisters during this Advent season through our unlimited love for all people, overflowing mercy, unconditional forgiveness, and humble service. We will be able to accomplish this witnessing mission of radiating Christ's Light by being united with God through our daily prayers, by frequenting the Sacrament of Reconciliation, by attending and taking part in the Eucharistic celebration, by reading the Bible, and by performing works of charity and mercy wherever we see these are needed.

John the Baptist was a voice crying in the wilderness, a voice to invite people into relationship with God. We too are asked to use our voice to make Christ known. We can use our gift

of communication to spread faith in Christ and illustrate his values and his attitudes. In our behavior too, we can let the Lord communicate through us. If we realize our calling to be witnesses to the light, it can shape how we live and explains why we live the way we do. Advent is a good time to reclaim our fundamental identity, our Christ-linked identity. If Jesus is to be born anywhere today, it will be in the hearts of his followers who are renewed and ready to be witnesses of our faith.

For those parishioners who do not attend Mass, but desire to receive any of these items, Mike & Lynne Dreelin have offered to deliver them as a convenience to you. Another way to receive them is to come by the church and pick them up during office hours.

WHAT WILL BE YOUR LEGACY?

One of the simplest ways to leave a gift to our church is to use the beneficiary designation on savings and retirement accounts, as well as life insurance policies. These can be done with no cost, and typically only require us to sign a new beneficiary designation form.

Retirement assets and similar accounts are called Income in Respect of a Decedent (IRD) assets. This is taxable income that's earned during life but not received before death, so it is never included in an income tax return. This may be assets in Individual Retirement Accounts or403(b) plans, accrued interest on Certificates of Deposit and savings bonds, nonqualified stock options, deferred payments of capital gains, or other income that is earned but not acquired.

In most cases, naming the church as the beneficiary of these types of assets gives the estate and heirs the best tax benefits, since it avoids both income and estate taxes.

THE 3RD SUNDAY OF ADVENT

This week's candle is the Shepherd's Candle which is pink or rose, representing Gaudete Sunday and the Joy that the Birth of Christ brought to the world.

What is special about the Third Sunday of the Church's history, this Sunday had a special name. "Gaudete" Sunday. On this day the season of Advent shifts its focus. For the first two weeks of Advent, the focus can be summed up in the phrase, "The Lord is coming," But beginning with Gaudete Sunday, the summary might be, "The Lord is near." This shift is marked by a lighter mood and a heightened sense of joyous anticipation. Liturgically, the colors lighten as well. The priest usually wears rose colored vestments, a hue seen only on Gaudete Sunday and Laetare Sunday. On this day, we light the third candle of the Advent wreath, which is also rose-colored, or if you prefer, pink.
